Cllr Bishop delivered the Chairman's report in which she highlighted a number of significant challenges for the Council including an increase in operational costs due principally to an increase in the costs associated with the Parish Clerk and also the uncertainty of the future of the local Bus Service. On the positive side there is now funding available to make improvements to the Playing Field facilities and the Council is continuing press BT for the supply of Superfast Broadband. Also the Council has made an application to the British Heart Foundation for the supply of a defibrillator to the village, news on which is expected soon. Finally the Village's Annual Litter Pick will take place over the weekend of  $3^{\rm rd}/4^{\rm th}$  June.

5.	DISTRICT COUNCILLOR'S REPORT
	Dist Cllr O'Reilly-Cicconi reported on the results of the recent BDC survey in
	which 92% of responders considered Braintree to be a "good place to live". 86%
	are satisfied with the way in which the Council is run and 60% think that the
	Council is doing a good job. There was also a positive reaction to the Energy
	Switch Scheme run by BDC. He reported that BDC is now running a pilot scheme
	for the protection of vulnerable residents. The District Investment Strategy is
	considering a variety of different investments for BDC such as property and
	also improved Health provision. Dist Cllr O'Reilly-Cicconi reported that he is now
	no longer on the BDC Planning Committee and therefore he is able now to give to
	any committee quite freely. On the matter of the Local Bus Service he
	confirmed that the replacement service (Dart3/Arrow taxis) does not cover
	Little Maplestead Finally he asked the Parish Clerk to email contact details for
