Cllr O'Reilly-Cicconi reported on the following

- Planning Training for clerk and Councillors to cover the new delegation scheme and recent changes in planning law. Cllrs Cooper, Grocott and the clerk will attend.
- BDC have launched a Business Growth Loan fund for capital investment loans between £5,000 and £100,000 for companies located in or moving in to Braintree District. Full details are available at www.braintree.gov.uk/businessloan
- Essex County Council's bid for increased devolution for Essex was submitted in September. The next stage update is expected in November.

5. PUBLIC FORUM

3 residents of Collins Road attended to express their concerns about planning application 15/00951/OUT Land East Of Aster Cottage Collins Road CO9 2SG. It was pointed out that in the 2011 Local Development Framework, Little Maplestead Parish Council stated that building was not wanted outside the village envelope and now appears to have reversed that decision by not objecting to this planning application. Cllr Cooper explained that this is a completely new Parish Council since 2011 and advised that objections to any planning application should be communicated to the Parish Council before the response deadline in order for Councillors to represent parishioners effectively.
